Definition of Prosperity:

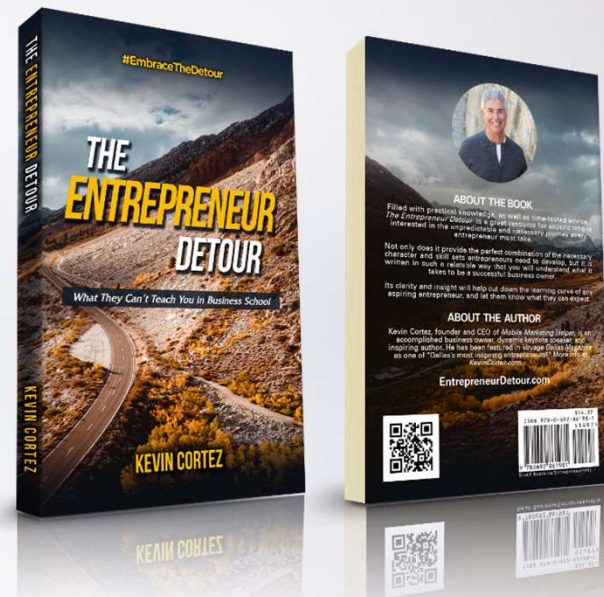
You have no financial debt

created you to be?”

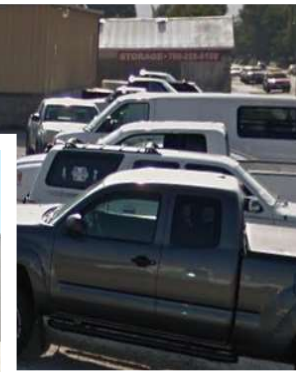

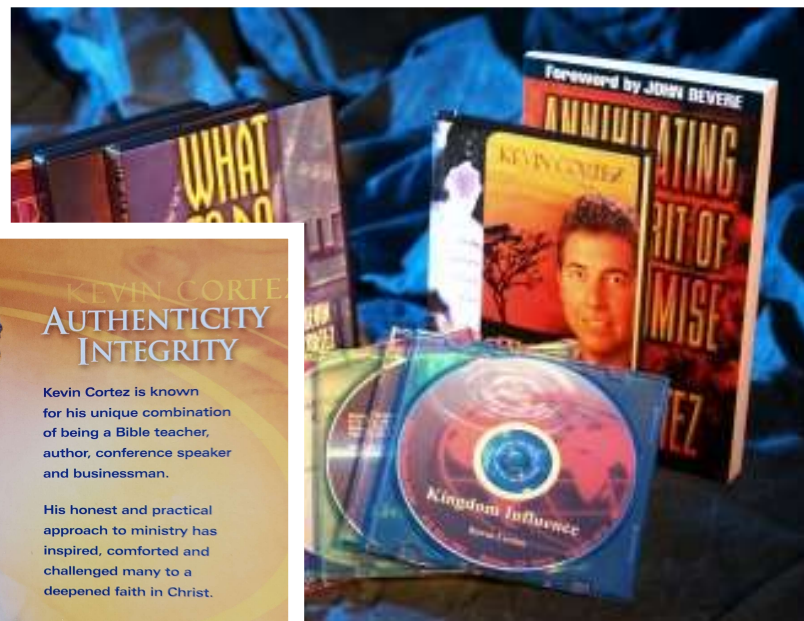


“Helps” is the Greek word antilēmpsis which literally means “laying hold of” revelation.
